### **ROLE AND RESPONSIBILITIES**

This role is responsible for providing site safety administrative support, monitoring workplace activities and ensuring compliance with safety protocols and procedures on our Springfield, NE job site.

- Develop efficient system to track and upload safety and training documentation.
- Review and maintain safety records and document appropriately and timely (i.e. Toolbox talks, Inspection, Pre-Task Plans).
- Filing all required documentation regarding the scope of the project.
- Coordinate new hire orientation.
- Ensure employees and subcontractors are attending jobsite orientation, developing and submitting Job Hazard Analysis.
- Ensure compliance with OSHA and site regulations.
- Provide logistical support for Safety trainings and meetings.
- Maintain inventory of safety equipment.
- Monitor safety performance of on-site workers to determine vulnerability.
- Ensure workers are wearing the proper PPE.
- Educate workers about the company's safety policy and procedures.
- Complete special projects and duties assigned by the Safety Department or Project Management.
